NO.GH/SH/29/2011/PVS/102010/543/S:- In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj. 2 of 2008), the Government of Gujarat hereby makes the following rules further to amend the Master of Business Administration Course (Regulation of Admission and Payment of Fees) Rules, 2008, namely:-

- 1. These rules may be called the Master of Business Administration Course (Regulation of Admission and Payment of Fees) (Second Amendment) Rules, 2011.
- 2. In the Master of Business Administration Course (Regulation of Admission and Payment of Fees) Rules, 2008, after rule 5, the following rule shall be inserted, namely:-
- "5A. Special Provisions relating to admission in Amrut Modi School of Management of Ahmedabad University.-Notwithstanding anything contained in these rules, admission for the academic year 2011-2012, in the Master of Business Administration Course in Amrut Modi School of Management, Ahmedabad a constituent college of the Ahmedabad University, shall be granted in the following manner, namely:-
- (a) seventy-five percent seats including 15% of NRI seats, of the total sanctioned seats shall be filled in by the candidates who have appeared in the Gujarat Common Entrance Test (GCET), on the basis of the merit order obtained therein;

(b) twenty-five percent seats of the total sanctioned seats shall be filled in by the candidates who have appeared in the Common Admission Test (CAT) conducted by the Indian Institute of Management, on the basis of the merit order obtained therein.
