**No: GH/SH/11-2016/VVA-1197-452-L:-** In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Senior Superintendent, Class II, in the Gujarat Education Service (Administrative Branch) , namely:-

1. These rules may be called Senior Superintendent, Class II, in the Gujarat Education Service (Administrative Branch), Recruitment Rules, 2016.
2. Appointment to the post of Senior Superintendent, Class II, in the Gujarat Education Service (Administrative Branch), shall be made, either,-
  - (a) by promotion of a person of proved merit and efficiency from amongst the persons, who
    - (i) have worked for not less than five years in the cadre of Junior Superintendent, Class II, in the

Gujarat Education Service;

(ii) have passed the prescribed departmental examination for promotion to the post of Senior Superintendent, Class II, in the Gujarat Education Service;

(iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in-sub clause (i) above; or

(b) by direct selection.

3. Appointment by promotion and direct selection shall be made in the ratio of 1 : 3, respectively.

4. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,

(a) not be more than 40 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

Provided further that nothing contained in clause (b) of sub-rule (9) of rule 8 of the Gujarat Civil Service Classification and recruitment (General) Rules, 1967 shall be applicable in so far as

relaxation of upper age limit as prescribed above is concerned;

(b) possess –

- (i) a bachelors degree with second class obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognized as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956 or possess an equivalent qualification recognized as such by the Government,
- (ii) about five years experience of administration in the Government or Panchayat or Local Bodis or University or grant-in-aid or non-Grant-in-aid private primary school or upper primary school or secondary education school or higher secondary education school or primary education adhyapan mandir or District Institute of Education and Training; or B.Ed. college or

grant- in-aid collage, on the post which can be considered equivalent to the post not below the rank of Auditor Group-1, Class-III or Head Clerk, Class III;

C possess basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

(D) adequate knowledge of Gujarati or Hindi or both.

5. The candidate appointed by direct selection shall be on probation for a period of two years.

6. The candidate appointed by direct selection shall, during his probation period require to undergo pre-service training and pass the post-training examination in accordance with the provisions of the Gazetted Officer's Pre-Service (Training and Examination) Rules, 1970.

7. The candidate appointed by direct selection shall, during his probation period, require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination rules, 2006.
  
8. The candidate appointed by direct selection shall require to pass an examination in Gujarati or Hindi or both in accordance with the rules prescribed by the Government.
  
9. The candidate appointed by direct selection or by promotion shall have to undergo such training and pass such examination as may be prescribed by the Government.
  
10. The candidate appointed by direct selection shall require to furnish a security and surety bond in such form, for such amount and for such period as may be

prescribed by the Government.
