No:GH/SH/17/2011/PVS/102011/335/S: In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj. 2 of 2008), the Government of Gujarat hereby makes the following rules further to amend the Bachelor of Engineering and Technology, Bachelor of Pharmacy and Diploma in Pharmacy (Regulation of Admission and Payment of Fees) Rules, 2008 as follows, namely:-

1. These rules may be called the Bachelor of Engineering and Technology, Bachelor of Pharmacy and Diploma in Pharmacy (Regulation of Admission and Payment of Fees) (3<sup>rd</sup> Amendment) Rules, 2011.

2. In the Bachelor of Engineering and Technology, Bachelor of Pharmacy and Diploma in Pharmacy (Regulation of Admission and Payment of Fees) Rules, 2008 (hereinafter referred to as "the said rules"), in rule 2, after clause (b), the following clause shall be inserted, namely:-

“(bb) “AIEEE” means All India Engineering Entrance Examination conducted by Central Board of Secondary Education, New Delhi, for the purpose of admissions to the professional courses;”.

3. In the said rules, in rule 5,-


(a) for sub-rule (1), the following sub-rule shall be substituted, namely :-

“(1) For the purpose of admission, a candidate shall have passed the qualifying examination from,-

(i) the Gujarat Board; or

(ii) the Central Board of Secondary Education Board:

Provided that,-



(a) the school in which the candidate has studied, shall have been located in the State of Gujarat; or

(b) the school in which the candidate has studied, shall have been located in the Union Territories of Diu, Daman and Dadra Nagar Haveli and whose parents are origin of Gujarat; or

(iii) the Council of Indian School Certificate Examination, New Delhi:

Provided that,-

(a) the school in which the candidate has studied, shall have been located in the State of Gujarat; or

(b) the school in which the candidate has studied, shall have been located in the Union Territories of Diu, Daman and Dadra Nagar Haveli and whose parents are origin of Gujarat; or

(iv) the National Institute of Open Schooling:

Provided that,-

(a) the study centre/school in which the candidate has studied, shall have been located in the State of Gujarat; or

(b) the study centre/school in which the candidate has studied, shall have been located in the Union Territories of Diu, Daman and Dadra Nagar Haveli and whose parents are origin of Gujarat; or

(v) the International School Board:

Provided that,-

(a) the study centre/school in which the candidate has studied, shall have been located in the State of Gujarat; or

(b) the study centre/school in which the candidate has studied, shall have been located in the Union Territories of Diu, Daman and Dadra Nagar Haveli and whose parents are origin of Gujarat; and

(iv) have appeared in the Gujarat Common Entrance Test conducted in the current academic year,-

In case of,-

(a) a degree in engineering or technology course, passed with minimum 50% marks (45% marks for SC/ST/SEBC

candidates) in theory and practical in Physics, Mathematics as compulsory subjects with either Chemistry or Biology or Biotechnology subject;

(b) a degree or diploma in pharmacy course, passed with minimum 50% marks (45% marks for SC/ST/SEBC candidates) in theory and practical in Physics, Chemistry as compulsory subjects with either Mathematics or Biology or Biotechnology subject .”;

(b) sub-rule (2) shall be deleted;

(c) for sub-rule (3), the following sub-rule shall be substituted, namely :-

“(3) A candidate whose parents are origin of Gujarat and are serving out of Gujarat in the service of Central Government or other State Governments, Military, Boards or Corporations owned or controlled by the Central Government or other State Governments or any nationalized bank and who has passed the qualifying examination from the State where the parents are serving and appeared in the Gujarat Common Entrance Test conducted in the current academic year, shall be eligible for admission and his candidature shall be included in the second merit list as prescribed in sub-clause (ii) of sub-rule (2) of rule 11.”.

**4.** In the said rules, in rule 6, in sub-rule (7), after the words “such admission shall be cancelled” the words “at any point of time” shall be added.

**5.** In the said rules, in rule 7, in the Explanation, for the words “medical authority”, the words “competent medical authority” shall be substituted.

**6.** In the said rules, in rule 10, for sub-rule (2), the following sub-rule shall be substituted, namely:-

“(2) (i) the Tuition Fee Waiver Scheme shall be applicable to all the sanctioned seats of the engineering and pharmacy courses in the Government colleges or institutions , grant-in-aided colleges or institutions and unaided colleges or institutions approved by AICTE, New Delhi;

(ii) the supernumerary seats not exceeding five percent of sanctioned intake of the colleges or institutions shall be filled on the basis of merit of the candidate, the annual income of whose parents is less than Rs. 2.5 lakhs from all sources of income;

(iii) the supernumerary seats for Foreign Nationals or Persons of Indian Origin (PIO) or the children of Indian workers in Gulf countries not more than 15% of the sanctioned intake shall be applicable to all the Government Colleges or institutions, grant-in-aid colleges or institutions or unaided colleges or institutions approved by AICTE, subject to the condition that upto 1/3<sup>rd</sup> of the 15% shall be reserved in the different disciplines in all the college or institution, for the Children of Indian Workers in the Gulf Countries. The remaining seats of such category shall be reserved for the Foreign Nationals or Persons of Indian Origin (PIO). The Foreign Nationals or Persons of Indian Origin (PIO) or the children of Indian Workers in the Gulf Countries admitted through Indian Council for Cultural Relation (ICCR or as Government of India nominee) shall be included in their respective category;

(iv) the supernumerary seats which remains vacant shall not be offered to anyone other than the respective category.

(v) the Tuition Fee Waiver Scheme shall be for the complete duration of the course and the students admitted under this scheme shall not be allowed to change the institution or the course under any circumstances.

**7.** In the said rules, in rule 11,-

(a) for sub-rule (2), the following sub-rule shall be substituted, namely:-

“(2) The Admission Committee shall prepare and publish **three** separate merit lists, namely:-

(i) The first merit list shall include the candidates who have passed the qualifying examination from the Gujarat Board. Merit list of reserved category candidates shall be prepared separately;

(ii) The second merit list shall include the candidates who have passed the qualifying examinations from the Central Board of

Secondary Education. Merit list of reserved category candidates shall be prepared separately; and

(iii) The third merit list shall include the candidates who have passed the qualifying examination from the Council of Indian School Certificate Examinations, New Delhi or National Institute of Open Schooling or International Board. Merit list of reserved category candidates shall be prepared separately;

(iv) The available Seats shall be distributed on pro-rata basis taking into considerations the number of students passed from the boards mentioned in (i), (ii) and (iii) above, in the current academic year.”;

(b) in sub-rule (3), for clause (d) the following clause shall be substituted, namely:-

“ (d) Aggregate marks obtained in qualifying examination (Standard 12), and ”.

**8.** In the said rules, rule 15 shall be deleted.


**9.** In the said rules, in rule 16, for sub-rule (1), the following sub-rule shall be substituted, namely:-

“(1) A candidate who gets admission shall have to pay such fees, as may be determined by the Fee Regulatory Committee constituted under section 9 of the Act, for unaided colleges or institutions, at such stages, as may be determined by the Admission Committee.”.

**10.** In the said rules, in rule 21, in sub-rule (2), after clause (ii) the following clause shall be inserted, namely;

“(iii) after allotting the seats to candidates mentioned in sub-clauses (i) and (ii) above, if any seat remains vacant, the institute shall invite application from the candidates who have passed diploma engineering course and grant admission on merit. Such candidates shall be eligible for admission in first year of engineering only.”.
