Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007. **NO. NO. GH/SH/21/PVS/102011/336/S :-** In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj. 2 of 2008), the Government of Gujarat hereby makes the following rules further to amend the Master of Business Administration Course (Regulation of Admission and Payment of Fees) Rules, 2008, namely:-


1. These rules may be called the Master of Business Administration Course (Regulation of Admission and Payment of Fees)(Amendment) Rules, 2011.

2. In the Master of Business Administration Course (Regulation of Admission and Payment of Fees) Rules, 2008 (hereinafter referred to as "the said rule"), in rule 11, in sub-rule (2), for clause (iii), the following clause shall be substituted, namely:-

“(iii) Total of the marks obtained in quantitative and general knowledge sections of GCET,”.


3. In the said rules, for rule 17, the following rule shall be substituted, namely:-

“17. In case the seats remain vacant after the completion of admission process **or where** the seats remain vacant after the offers have been made for all the available seats, such vacant seats shall be displayed on the official *web-site*, on the notice board of the office of the Admission Committee and the same may be intimated to the concerned Institution. In case any eligible candidate requires admission on such vacant seat, he shall apply directly to the concerned Institution. Such seats shall be filled by the eligible candidates of Gujarat State and if any seats still remain vacant, the same shall be filled by the candidates who have passed the qualifying examination with at least 50% marks from any of



the Universities or institutes situated outside Gujarat State and have appeared in GCET/CAT/MAT or any other such test conducted in the current year, by any agency approved by AICTE. The concerned Institution shall carry out admission for such seats by maintaining inter-se merit of the applications received by them.”.


1. These rules may be called the Master of Computer Application Course (Regulation of Admission and Payment of Fees) (Amendment) Rules, 2011.

2. In the Master of Computer Application Course (Regulation of Admission and Payment of Fees) Rules, 2008 (hereinafter referred to as "the said rule"), in rule 11, in sub-rule (2), for clause (iii), the following clause shall be substituted, namely:-

“(iii) Total of the marks obtained in quantitative and analytical sections of GCET,”.


3. In the said rules, for rule 17, the following rule shall be substituted, namely:-

“17. In case the seats remain vacant after the completion of admission process or where the seats remain vacant after the offers have been made for all the available seats, such vacant seats shall be displayed on the official *web-site*, on the notice board of the office of the Admission Committee and the same may be intimated to the concerned Institution. In case any eligible candidate requires admission on such vacant seat, he shall apply directly to the concerned Institution. Such seats shall be filled by the eligible candidates of Gujarat State and if any seats still remain vacant, the same shall be filled by the candidates who have passed the qualifying examination from any of the Universities or institutes situated outside



Gujarat State and have appeared in GCET/CAT/MAT or any other such test conducted in the current year, by any agency approved by AICTE. The concerned Institution shall carry out admission for such seats by maintaining inter-se merit of the applications received by them.”.
