OF INDIA.

NO-GH/SH/4/NCC/1707/2351/KH:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules for regulating recruitment to the post of Ship Modeling Instructor, Class III, in the Subordinate Service of the Directorate of National Cadet Corps, namely:-

1. These rules may be called the Ship Modeling Instructor, Class III, Recruitment Rules, 2011.
2. Appointment to the post of Ship Modeling Instructor, Class III, shall be made by direct selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-

(a) not be more than 28 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (b) possess a degree obtained from any of the Universities or institutions established or incorporated by or under the Central or State Act in India: or any other educational institution recognized as such or declared as deemed a University under section 3 of the University Grants Commission Act, 1956 or possess an equivalent qualification recognized by the Government; and
- (c) possess "C" level Certificate issued by the Naval Wing of the National Cadet Corps; and
- (d) have actively undergone the Ship Modelling Training during his tenure of National Cadet Corps; and
- (e) have represented as Ship Modelling Cadet in the unit in Republic Day Camp, New Delhi or Nau Sainik Camp or both; and

(f) possess a knowledge of constructing, operating and repairing of the following categories of Ship Models namely:-

- (i) Static Model,
- (ii) Sailing Models,
- (iii) Power Models and
- (iv) Radio Controlled Power Models;

(g) have knowledge of Ship Modeling;

(h) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and

(i) possess adequate knowledge of Gujarati and /or Hindi.

4. The candidate appointed by direct selection shall be on probation for a period of one year.
5. The candidate appointed by direct selection shall, during his probation period, be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
6. The selected candidate will be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
7. The candidate appointed by direct selection shall have to undergo such training and to pass such examination as may be prescribed by the Government.
8. The selected candidate shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
